### Elemental Values of Minerals:

Minerals do not normally occur as pure mineral, but rather, as part of complex molecules. Some common examples are calcium citrate (calcium combined with citric acid to form calcium citrate) or chelated iron (iron bound to amino acids and/or small proteins). In each case, the calcium or iron accounts for less than 25% of the total weight of the actual substance. Therefore, it is important to know how much actual calcium or iron is in each tablet or capsule. The supplement should state the actual amount of the mineral in question. A supplement may read, "100 mg of calcium from calcium citrate". In this case there would be 100 mg of elemental calcium, but the calcium citrate would weigh 500 mg. It would take 12 of the capsules to obtain the entire RDA for calcium (1200 mg).

### International Units (IU):

These are activity units and not weights, however comparisons can be made.  
 Vitamin A: 1 IU is equal to 0.300 mcg of all-trans retinol  
 Vitamin D: 1 IU is equal to .025 mcg of vitamin D<sub>2</sub> or D<sub>3</sub>  
 Vitamin E: 1 IU of vitamin E activity is equal to 0.672 mg [d]-alpha-tocopherol.

### Vegetarian Capsules

Daily Manufacturing is now using vegetarian capsules (Vcap) in all encapsulated products—except softgel capsules (which are not available). This represents a substantial cost to us, but we believe that it adds quality to our products. Vegetarian capsules are made from a plant derived cellulose and are digested as easily and rapidly as gelatin capsules.

In most cases it is easy to determine everything that goes into your supplement just by reading the label. FDA labeling regulations require that all active ingredients be listed in the “Supplement Facts” box, and other ingredients be listed beneath as “Other Ingredients.” This is a reasonable regulation that allows the consumers to know exactly what they are taking. It is frequently necessary to use excipients to maintain a consistent capsule weight or even to make a product at all. We use only excipients that are safe and natural, and in some cases even contribute to the nutritional content. We only use excipients when we absolutely must, in order to produce a quality product. Many Daily supplements have no excipients. The list of excipients below explain what they are and why they are used. The identifying codes can be used to tell what excipients are in the products listed. The letter codes are at the end of each product description in parenthesis. The following excipients may be used in Daily products. Each name is followed by an alphabetical code that is used at the end of each product description to indicate what excipients are used. If a product contains any of the excipients below, it will be indicated in the product description and on the label.

#### (Non-Active Ingredients)

**No Excipients (NE):** Many products contain no excipients.

**Cellulose (C):** Also known as microcrystalline cellulose. A purified plant fiber used as a filler, flowing agent, and aids tablet disintegration. Besides aiding in manufacturing, cellulose supplies a high quality dietary fiber.

**Chlorophyll (CL):** Natural plant material used as a protective coating on tablets.

**Croscarmellose Sodium (CS):** This form of cellulose absorbs large quantities of water and expands rapidly. This is used in small amounts to help tablets disintegrate. This effectively eliminates the problem of undigested tablets.

**Magnesium Stearate (MS):** Magnesium stearate is made by combining magnesium with vegetable oils. Magnesium stearate assists in allowing ingredients to flow into tablet dies and capsules.

**Shellac (S):** A natural coating produced from tree resins by insects and collected by farmers in India. Used on a few tablets that need protection from oxygen and moisture.

**Silicon Dioxide (SD):** A natural silica used as an anti-caking agent, that allows “sticky” materials to flow. All silica is poorly absorbed, but does add some silicon to the diet. Typically used in concentrations of 1% or less.

**Soybean Oil (SO):** This natural vegetable oil is frequently included in soft-gel capsules containing fat soluble vitamins or oils.

**Stearic Acid (SA):** A natural vegetable oil often used as a lubricant to allow difficult agents to flow. Used in small amounts (usually 2% or less) therefore, not adding significant calories from fat.

## A & D Vitamins

**Extra-A Plus & Vegetarian Extra-A:** These products contain 25,000 units of vitamin A. The **Extra-A Plus** has 8,333 IU from each of the following: beta-carotene, fish liver oil and vitamin A palmitate. The **Vegetarian Extra-A** is a vegetarian formulation that has 12,500 IU of vitamin A from beta-carotene and 12,500 IU of vitamin A palmitate. The beta-carotene is a natural source from mixed carotenoid that also contains alpha-carotene, cryptoxanthin, lutein, zeaxanthin, and lycopene. Vitamin A activity is only claimed for the beta-carotene, but the other carotenoids have other important biological activities, and some are even more powerful antioxidants than beta-carotene. A combination of carotenoids is more natural, since foods contain all of the carotenoids. There is also an extra margin of safety when some of the vitamin A activity is provided in the carotenoid form. Carotenoids are essentially non-toxic, even at high doses. In contrast to pre-formed vitamin A, which is toxic at high doses. **Extra-A Plus** and **Vegetarian Extra-A** are both available in bottles of 100 and 250 capsules. (C, MS)

**A&D:** Each softgel capsule contains 10,000 IU of vitamin A and 400 IU of vitamin D<sub>3</sub> from fish liver oil. **A&D** is available in bottles of 100 and 250 capsules. (Cod Liver Oil, SO)

**Vitamin D<sub>3</sub>-1000:** Each capsule contains 1000 IU of vitamin D<sub>3</sub>. **Vitamin D<sub>3</sub>-1000** is available in bottles of 100 capsules. (C, MS)

**Vitamin D<sub>3</sub>-5000:** Each capsule contains 5000 IU of vitamin D<sub>3</sub>. **Vitamin D<sub>3</sub>-5000** is available in bottles of 100 capsules. (C, MS)

## B Vitamins

**Activated B6:** Conventional vitamin B6 is in the form of pyridoxine hydrochloride. In order for the body to use pyridoxine hydrochloride, it must be processed by the body into the coenzyme form, Pyridoxal-5-phosphate. The processing of pyridoxine requires two energy utilizing steps, catalyzed by the enzymes pyridoxal kinase and pyridoxine phosphate oxidase. **Daily B6** is the coenzyme form, eliminating the need for processing by the body. It is like a plug in module and is much more efficiently used than the regular type. Each capsule contains 50 mg and is available in bottles of 100 capsules. (C, MS)

**Activated B-12:** **Activated B-12** contains equal amounts of 5-deoxyadenosyl cobalamin and methylcobalamin. These are the active forms of vitamin B-12. For normal absorption, B-12 requires intrinsic factor; but even without intrinsic factor, 1-2% of B-12 can be absorbed. Therefore, since there are 500 mcg per capsule, considerably more than the RDA of 2 mcg should be absorbed by anyone taking it. **Activated B-12** is available in bottles of 180 capsules. (C, MS)

**Activated B-Complex:** Each capsule contains active forms of B6 (10 mg),

B12 (20 mcg), thiamine (10 mg), and riboflavin (10 mg). There is also niacinamide (40 mg), niacin (20 mg), folic acid (200 mcg), pantothenic acid (10 mg), PABA (20 mg), biotin (150 mcg), choline (20 mg), and inositol (20 mg). All of the B vitamins are provided in the forms best utilized by the human body. Available in bottles of 100 and 250 capsules. (C, MS)

**Folic Acid:** Each tablet contains 800 mcg of folic acid in a slotted tablet that can be broken in half for a 400 mcg dose. **Folic Acid** is available in bottles of 100 and 250 tablets. (C, MS)

**Niacin:** Niacin (nicotinic acid) is used in the body to make nicotinamide adenine dinucleotide (NAD) and NAD-phosphate, which supplies energy for many catabolic and anabolic reactions. Niacin will cause a transient niacin flush with redness and a burning sensation in the skin. The niacin flush is uncomfortable but harmless for most people - possible exceptions are persons with asthma or peptic ulcers. **Niacin** is available in bottles of 200 tablets supplying 100 mg per table. (C, Calcium Sulfate, SD, SA, MS)

## C Vitamins

**Acerola Cherry:** Our all-natural vitamin C tablets from acerola cherries can be chewed or swallowed, and have a pleasant tart flavor. Each tablet contains 60 mg of vitamin C. **Acerola C** is available in bottles of 60 tablets. (SA, sorbitol, vanilla)

**Lemon C:** Lemon C contains 500 mg of vitamin C and 150 mg lemon bioflavonoid complex. **Lemon C** is available in bottles of 120 capsules. (SD, MS)

**Spectra-Scorb:** **Spectra-Scorb** vitamin C is in the form of mineral ascorbates; containing 500 mg of vitamin C per tablet, plus 100 mg of mixed bioflavonoids and the following amount of minerals from the mineral ascorbates: potassium (30 mg), calcium (26.5 mg), magnesium (13.5 mg), zinc (1.75 mg), and manganese (630 mcg). **Spectra-Scorb** is an excellent source of vitamin C as well as minerals that are easily absorbed. **Spectra-Scorb** is available in bottles of 100 tablets. (Calcium phosphate, C, SA, MS, Silica)

**Spectra-Scorb Plus:** **Spectra-Scorb Plus** contains mineral ascorbates in an 8 hour sustained release tablet, with a chlorophyll coating. Each tablet contains 1000 mg of vitamin C per tablet, along with 100 mg of the following blend: hesperidin, rose hips, acerola cherry, pectin, orange, lemon, grapefruit, and rutin. The mineral ascorbates provide the following amounts of elemental minerals: calcium (60 mg), magnesium (24 mg), zinc (2.5 mg), potassium (70 mg) as citrate-aspartate, not ascorbate), manganese (125 mcg), and molybdenum (200 mcg). **Spectra-Scorb Plus** is available in bottles of 120 tablets. (C, SA, MS, Silica, CL)

**Spectra-Scorb Powder:** **Spectra-Scorb Powder** is a blend of calcium, magne-

sium, potassium and zinc ascorbates with quercetin and lemon bioflavonoids. 1/2 teaspoon contains 1000 mg of vitamin C. This product is available in a 10 oz jar. (NE)

### E Vitamins

**Dry Vitamin E:** This Dry Vitamin E contains 400 IU (d-alpha tocopheryl acid succinate) from soy oil in vegetarian capsules. This form has less oil and a longer shelf life than the oil type capsules. **Dry Vitamin E** is available in bottles of 100 capsules. (C, MS)

**Vitamin E:** Natural d-alpha tocopherol from mixed tocopherols is the most natural form of vitamin E. While vitamin E activity is only claimed for the alpha tocopherol, the other naturally occurring tocopherols may have biological activity as well. This high quality natural **Vitamin E** is available in two strengths: 400 unit (100 softgel capsules), and 1000 unit (50 softgel capsules). (SO)

**Tocotrienols:** Each softgel capsule contains 50 mg of tocotrienols from rice, and 100 IU of d-alpha tocopherol vitamin E. **Tocotrienol** is available in bottles of 60 softgel capsules. (gelatin, glycerin and water)

### Calcium—Minerals

**Cal II:™** A very alkaline calcium supplement, utilizing a natural source of calcium carbonate and calcium hydroxide with brewer's yeast for added assimilation (Reams formula). Six capsules provide 1000 mg of elemental calcium. **Cal II™** is available in bottles of 100 and 250 capsules. (Brewer's Yeast, C, SD, MS) \*This product is also available in a yeast free form. **Cal II Yeast Free** is available in bottles of 100 and 250 capsules. (C, SD, MS)

**Cal II Supreme:** **Cal II Supreme** is a highly alkalizing mineral supplement made from premium quality coral calcium from Okinawa, Japan, and natural calcium hydroxide from earth deposits in the USA. Although primarily a calcium supplement, **Cal II Supreme** contains small amounts of numerous naturally occurring trace elements and 1 mg each of cesium and rubidium. **Cal II Supreme** has been carefully formulated to provide powerful ionic alkaline support by supplying highly active mineral derived anions. This product contains soy protein. **Caution:** This product contains powerful alkaline minerals: never chew capsules and take with at least 8 oz of water. **Cal II Supreme** is available in bottles of 100 and 250 capsules. (MS, SD)

**Calcium Aspartate:** **Calcium Aspartate** is a calcium salt of the amino acid, aspartic acid, that has a neutral reaction in the body. Medical research has shown it to be a well absorbed form of calcium supplementation, supplying 100 mg of elemental calcium. Calcium aspartate and citrate are best for people

who are uncertain of the acid-base balance of their bodies. This is a great source of calcium for everyone. **Calcium Aspartate** is available in bottles of 150 capsules. (MS, SD)

**Calcium Citrate:** Calcium Citrate is another form of calcium that has a neutral reaction in the body. Calcium citrate is a calcium salt of citric acid, which is an intermediate in the "Krebs Cycle". This product is also a form of calcium that works well for everyone. There is 100 mg of elemental calcium per capsule. Calcium Citrate is available in bottles of 150 capsules. (MS, SD)

**Calcium Gluconate:** Calcium Gluconate is a neutral, easily assimilated form of calcium. This is a calcium salt of gluconic acid made from calcium carbonate and gluconic acid from beets. There is 40 mg of elemental calcium per capsule. Calcium Gluconate is available in bottles of 100 and 250 capsules, (MS, SD), and 7 oz jars of powder. (NE)

**Calcium Lactate:** This milk type calcium is from a non-dairy source. It is naturally produced by fermentation of calcium carbonate with sugars and starches from potatoes. Calcium lactate is a more acid reacting form of calcium providing 280 mg of elemental calcium per 6 capsules. Calcium Lactate is available in bottles of 100 and 250 capsules. (MS, SD)

**Calcium Orotate:** A very well absorbed form of calcium popularized by Dr. Hans Neiper of Germany. Each capsule contains 60 mg of calcium from 545 mg of calcium orotate. Each bottle contains 90 capsules. (C, SD)

**Coral Calcium:** Coral Calcium is the highest quality Sango coral from Okinawa, Japan. Coral calcium is taken from land deposits of ancient coral, thereby assuring that coral reefs in the ocean are not disturbed. Coral calcium from land deposits are free of pollutants because the coral was formed long before modern man was there. All Daily coral products are mined and processed by strict Japanese pharmaceutical standards and further processed and packaged under strict American standards at Daily Manufacturing's FDA inspected facility. Daily Coral Calcium is ground extremely fine (7-10 micron); assuring that all of the calcium easily forms a colloidal suspension and is easily absorbed. Coral Calcium is available in bottles of 90 capsules or 8 oz. containers. (NE)

**Coral Calcium, Magnesium & Vitamin D<sub>3</sub>:** Coral calcium plus magnesium and vitamin D<sub>3</sub> in one capsule! This coral calcium combination contains 500 mg calcium (calcium carbonate) from Okinawa, Japan, 250 mg magnesium (carbonate) and 200 IU of vitamin D<sub>3</sub> per three capsules. Coral Calcium-Magnesium-Vitamin D<sub>3</sub> is available in bottles of 120 capsules or 5 oz. containers. (NE)

**Dairy Calcium:** Dairy Calcium is a high quality well absorbed form of pH neutral dietary calcium. Dairy Calcium is available in bottles of 90 capsule bottles. (MS) \* Does Contain Milk.

## Minerals

**Bone-Builder:** A wonderful blend of calcium (from calcium carbonate, citrate, phosphate and lactate), magnesium, vitamin D<sub>3</sub>, vitamin K<sub>1</sub>, vitamin C, silicon, boron and betaine hydrochloride. **Bone-Builder** is available in bottles of 120 capsules. (SA,CS, MS)

**Chromium Picolinate:** There are a number of chromium supplements on the market including GTF chromium, chromium polynicotinate, and others. All of the better chromium supplements, including chromium picolinate, are in a trivalent chemical state. Chromium picolinate has the advantage of being hypoallergenic since there is no yeast. Furthermore, most of the chromium research has used the picolinate form of chromium. Chromium picolinate is the best researched and most reliable form available. Each capsule contains 200 mcg of chromium from chromium picolinate. **Chromium Picolinate** is available in bottles of 100 capsules. (C, MS) **CAUTION:** Because chromium can increase insulin sensitivity, this may alter insulin requirements in diabetics. There is some evidence that persons with reactive hypoglycemia may also need to use caution with chromium. This applies to all forms of chromium, not just chromium picolinate. For this reason we need to include the following warning - Diabetics/Hypoglycemics: Use only under a physician's supervision.

**Colloidal Silver:** This colloidal silver suspension, at 20 ppm, is the ideal concentration providing optimal bactericidal and viracidal activity. **Colloidal Silver** is available in 4, 8 or 32 oz bottles. (NE)

**Dolomite:** Each capsule contains 144 mg of calcium and 68 mg of magnesium from dolomitic lime. This dolomite has been assayed for lead to assure that only very small trace amounts are present, posing no health hazard. **Dolomite** is available in bottles of 100 and 250 tablets. (NE)

**Ferro-Tonic:** **Ferro-Tonic** is an iron supplement in easy to assimilate liquid form. Eight drops contain 10.4 mg of elemental iron from a naturally occurring mined ferrous sulfate. **Ferro-Tonic** is available in a 2 oz dropper top bottle. (Distilled Water)

**K-Min:** **K-Min** is a blend of **Min-Col™** (302 mg) and diatomaceous earth (118 mg), supplying 78 mg of elemental calcium as calcium phosphate per capsule. **Caution: Pregnant women and animals** should never use this product. **K-Min** is available in bottles of 100 and 250 capsules. (NE)

**Lime Water:** A saturated calcium solution made with water from a specific well with a special sulfur compound to make the calcium more available. **Lime Water** is available in 12 oz and 32 oz containers. (NE)

**Liqui-Min:** We use mineral water from T.J. Clark in Utah. This source of ionized and colloidal liquid minerals is the original colloidal mineral water using lignite, which is derived from ancient vegetation (in between peat moss and

coal). Water is slowly dripped through the lignite, allowing it to accumulate the rich natural blend of easily assimilated trace elements. This is an excellent, hard-to-find source of trace elements. **Liqui-Min** is available in 32 oz. bottles. (NE)

**Magnesium Aspartate:** Magnesium aspartate is a magnesium salt of the amino acid, aspartic acid, that has a neutral reaction in the body. Medical research has shown it to be a well absorbed form of magnesium supplementation. Each capsule supplies 100 mg of elemental magnesium. Magnesium aspartate is an excellent choice for everyone needing supplemental magnesium. **Magnesium Aspartate** is available in bottles of 150 capsules. (MS, SD)

**Magnesium Citrate:** Magnesium citrate is a neutral salt of citric acid, an intermediate in the "Krebs Cycle". This is another form of magnesium that is well absorbed and that works well for everyone. There is 100 mg of elemental magnesium per capsule. **Magnesium Citrate** is available in bottles of 150 capsules. (MS, SD)

**Manganese:** **Manganese Citrate** contains 5 mgs per tablet. **Manganese Citrate** is available in bottles of 100 tablets. (C,CS)

**Mincol:**™ Colloidal size particles extracted from soft rock phosphate, from fossil deposits of ancient bones. This is a source of calcium and other minerals in a phosphatic colloidal form, and is also a rich source of the phosphate anion. Three capsules supply 324 mg of elemental calcium. **Min-Col**™ is available in bottles of 100 and 250 capsules. (MS)

**Potassium Aspartate:** **Potassium Aspartate** is a salt of the amino acid, aspartic acid, that has a neutral reaction in the body. It is a well absorbed form of potassium supplying 99 mg of elemental potassium from 450 mg of potassium aspartate per capsule. Potassium aspartate is an excellent choice for everyone needing supplemental potassium. **Potassium Aspartate** is available in bottles of 150 capsules. (C, MS)

**Potassium Citrate:** **Potassium Citrate** is a salt of citric acid that supplies 99 mg of elemental potassium from 275 mg of potassium citrate per capsule. This product is a well absorbed form of potassium. **Potassium Citrate** is available in bottles of 150 capsules. (C, MS)

**Potassium Iodide:** Potassium iodide has many uses in water purification, cleansing solutions, etc. Potassium iodide is a highly concentrated solution in distilled water and has 21.4 mg of iodine per drop. **Caution** should be used when treating foods with potassium iodide, since excessive iodine can impede thyroid function. Each dropper bottle contains 2 fl oz of potassium iodide solution. (Distilled water)

**Selenium:** Each tablet contains 100 mcg of selenium as an amino acid chelate. Each tablet is slotted so it can be easily broken in half for a 50 mcg dose. **Selenium** is available in bottles of 60 tablets. (C, CS)

**Tri-Min:** **Tri-Min** is a combination of three essential trace elements. Each tablet supplies: zinc (15 mg as amino acid chelate), manganese (10 mg as amino acid chelate), and selenium (50 mcg organically bound to yeast). **Tri-Min** is available in bottles of 100 tablets. (C, dicalcium phosphate, SA, SD, MS)

**Zinc:** Each tablet contains 30 mg of zinc as an amino acid chelate. Each tablet is slotted so it can be easily broken in half for a 15 mg dose. **Zinc** is available in bottles of 60 tablets. (C, CS)

### Digestive Care

**Betaine Hydrochloride:** Each capsule contains 10 grains, 648 mg of betaine hydrochloride, for use in assisting digestion. **Betaine Hydrochloride** is available in bottles of 100 and 250 capsules. (C, SD)

**Activated Charcoal:** Our activated charcoal capsules are made from plant products only. Charcoal is a powerful absorber of gas and toxins, but may also absorb nutrients and medications and should be used separately from them when possible. Please consult your doctor or pharmacist about use with medications. There are 260 mg of charcoal per capsule. **Charcoal** is available in bottles of 60 and 120 capsules. (NE)

**Colon-Aid:** Three capsules of **Colon-Aid** contain 750 million live *Lactobacillus acidophilus*, 750 million *Bifidobacterium bifidus* plus 1000 mg of Fructoolligosaccharides. **Colon-Aid** is kept refrigerated until shipped to keep the bacteria alive and healthy, and should be refrigerated after receiving it for maximum potency. **Colon-Aid** is available in bottles of 100 capsules. (C, MS)

**Digestine:** **Digestine** contains a broad spectrum of digestive enzymes. Each tablet contains: Pancreatin (140 mg of porcine), mycozyme (140 mg, an amylase enzyme isolate from fungi), papain (70 mg from papaya), pepsin (70 mg), betaine HCl (70 mg), and iron ox bile (65 mg bovine). The pancreatin is enteric coated for release in the small intestine (that will not release with pH below 6.8) thereby preventing denaturation of the active enzyme. In other words, we have coated the pancreatin so that it will not dissolve until it gets into the small intestine. **Digestine** is available in bottles of 100 tablets. (C, Maltodextrin, MS, SA)

**GlutenAce:** It is essential for persons with gluten intolerance to strictly avoid gluten containing foods. However, it is very difficult to completely eliminate all gluten, especially when eating away from home. GlutenAce is designed to help digest small amounts of gluten resulting from accidental contamination and to reduce gastrointestinal inflammation from eating gluten. Each capsule contains: 100 mg of BioCore DPP IV protease enzymes from *A. oryzae* (30,000 HUT, 500 DPP-IV) and (*A.melleus* 8.5 AP), 300 mg of bromelain (360 GDU), and 100 mg of quercetin. Each bottle contains 60 capsules. (MS, SD).

**L-Salivarius:** A potent probiotic supplement with approximately 2 billion live

*Lactobacillus salivarius* bacteria and 100 mg of fructooligosaccharides per capsule. This combination of probiotics and prebiotics can help establish a healthy intestinal flora. Each bottle contains 120 capsules. (C, SD, MS)

**Milk-Gest:** **Milk-Gest** is a vegetarian digestive enzyme supplement that assists with digesting both the lactose and proteins found in milk. Each capsule contains sufficient enzyme for the digestion of 2 cups of milk or 2 oz. of cheese. **Milk-Gest** is available in bottles of 100 capsules. (C)

**Miracle 7 Colon Cleanser:** A combination of psyllium seed husk powder (281 mg), bentonite (160 mg), citrus pectin (80 mg), *Lactobacillus acidophilus*, as well as an herbal blend that includes: wheat grass, apple fiber, golden seal root, gentian, buckthorn, rhubarb, cascara sagrada, whole leaf aloe vera, and spices.
